



2026-27 Grand Slam IWK Health Employee Lottery – Terms and Conditions

No more than 800 tickets will be sold on a first-come, first-served basis, and there is no limit on the number of tickets a participant can purchase. The odds of winning are based on the number of tickets sold. Tickets can be purchased through an online registration form on Pulse or by completing a paper form and sending it back to the IWK Foundation office.

The sale of tickets will terminate on October 13, 2026, at 11:59 p.m. ADT, unless all tickets are sold before that date. Tickets cost \$130 each and can be paid in full to Accounts Receivable at IWK Health or through an IWK Health payroll deduction of \$5 per ticket over 26 pay periods.

Entrants who order their ticket(s) on or before September 30, at 11:59 p.m., will be entered in a draw to win an Apple iPad16, 128GB, courtesy of belairdirect. The draw will take place on October 1, 2026.

Entrants are eligible to win \$500 in 26 biweekly draws and \$10,000 in the final grand prize draw. The biweekly draws will commence on October 29, 2026, and the grand prize draw will take place on October 28, 2027.

All employees of IWK Health are eligible to participate in the Grand Slam Staff Lottery, with the exception of Casual and Term Employees. IWK Health Centre Charitable Foundation employees are not eligible.

All entrants must be employees at the time of entry.

If an entrant purchases a ticket or tickets and has paid the full ticket price of \$130 and is not an employee of IWK Health at the time of the bi-weekly and grand prize draw is eligible to win.

If an entrant ceases to be an employee of IWK Health prior to their ticket(s) being paid in full, they are no longer eligible to win future prizes, and any active payroll deductions will stop effective on their last payroll. Any prize won before the employment end date is still valid to be won. There are no other instances where a refund will be permitted.

All Entrants must be of the Age of Majority at the time of entry.

Entries are non-transferable.

The control and the draw of the tickets will be the responsibility of the IWK Health Centre Charitable Foundation.

Winners give IWK Health Finance Department permission to process automatic deposit payment into their bank account.

Payment to winners will take 4-6 weeks to process.
