MAKE YOUR GIFT IN THREE EASY STEPS:

- 1. Download the Gifts of Securities form and please send the completed document to the IWK Foundation: IWK Donations Team
 - This is an important step because it notifies the IWK Foundation of your pending gift, allows us to accept the donation, and issue your tax receipt.
- 2. Initiate the share transfer. If applicable, contact your investment advisor who will have you sign a letter of direction outlining the shares you wish to donate. Please see details below.
- 3. When shares have been received, the IWK Foundation will call to thank you and confirm the value of your tax receipt.

Please note: All transfers of securities to the IWK Foundation are subject to review, approval and acceptance by the IWK Foundation. The value of your tax receipt will be based on the price on the day our custodian receives the securities in the Foundation account.

Please note that we are unable to issue a receipt for income tax purposes until we receive your donation.
