

Grand Slam IWK Employee Lottery – Terms and Conditions

Only 800 tickets will be sold on a first-come, first-served basis and there is no limit on the number of tickets a participant can purchase. The odds of winning are based on number of tickets sold.

The sale of tickets will terminate on October 14th, 2021, unless all tickets are sold before that date. Tickets cost \$130 each and can be paid in full, or through payroll deduction of \$5 per pay, per ticket.

Entrants who order their tickets(s) on or before September 30, 2021 will be entered in a draw to win an Apple 8th Gen iPad 10.2-inch, Wi-Fi, A12 Bionic Chip, 32 GB, iPad OS 14 courtesy of Johnson Insurance. The draw will take place on October 1, 2021.

Entrants are eligible to win \$500 in 26 biweekly draws and \$10,000 in the final grand prize draw. The biweekly draws will commence on November 4, 2021, and the grand prize draw will take place on November 3, 2022.

All employees of the IWK Health Centre are eligible to participate in the Grand Slam Staff Lottery. Crothall Services Canada employees are also welcome to participate, but must pay for their tickets(s) in full at the time of sign-up. IWK Foundation staff members are not eligible.

All entrants must be employees at the time of entry.

If an entrant purchases ticket/s and has paid the full ticket price but then becomes no longer an employee, he/she is still eligible to win through any subsequent bi-weekly and grand prize draws.

If an entrant ceases to be an employee prior to their ticket/s being paid in full, he/she will receive a refund for the amount that has been paid and will no longer be eligible to win.

Refunds will be processed by the IWK Health Centre's Finance department and take 4-6 weeks to process.

There are no other instances where a refund will be permitted.

All Entrants must be at the Age of Majority at the time of entry.

Entries are non-transferable.

The control and the draw of the tickets will be the responsibility of the IWK Foundation.

Winners give the Health Centre Finance Department permission to go to payroll to process automatic deposit payment.

Payment to winners will take 4-6 weeks to process.
